Northeastern Illinois University assumes no financial responsibility for international students. All international students are required to show proof that funds are guaranteed for the first year of study to obtain an I-20. Please ensure that adequate funding will continue to be available from the same or equally reliable sources for subsequent years. The following figures indicate the minimum amount needed for one academic year (fall & spring terms, minimum full-time enrollment) and twelve months of living expenses. Estimated costs may be higher or lower than shown. An international student on an F-1 or J-1 visa cannot sponsor another international student. If you are adding dependents you will need to provide additional expenses per year. Dependents are not permitted to work in the U.S.
