Core Application Requirements

1. Application for Admission to Graduate Programs: A non-refundable \$30 application fee is required with the application. Any application received without the application fee or waiver will not be processed.

Please do not send cash.

2. Two Letters of Recommendation and the Letter of Recommendation Forms: Letters and forms should be enclosed in an envelope with the recommender's signature across the back seal, or sent electronically via the online application. Letters should be from persons such as professors or employers who can attest to your qualifications. One letter should be from a former professor if you have been in school in the past five years.

Please note: some Education programs require a specific letter of recommendation, which will be noted in the Additional Requirements section.

- **3. Statement of Goals and Objectives:** Discuss your goals and objectives specific to your program of interest. Your statement should be two pages.
- **4. College Transcripts:** Current official transcripts from all colleges and universities attended. Official transcripts and examination scores must be in sealed envelopes from the sending college or institution or submitted via the sending institution's secure electronic system. Opened transcripts are not considered official. All documents submitted become the property of the University and will not be released to the student

or outside party for any reason. Courses taken at colleges or universities outside of the United States must be evaluated by a member of NACES (https://www.naces.org/members) for equivalence of our undergraduate degree. A course-by-course evaluation is required.

- **5.** International students must also submit official IELTS, Pearson PTE, or TOEFL report to Graduate Admissions.
- **6. Additional Required Documents:** Some programs may require test scores (GRE, GMAT, TAP), research papers, teaching license, or proof of prerequisite coursework. Additional program requirements can be found in the Academic Programs and Codes list on the following pages.
- 7. If you are a permanent resident, please submit a copy of your permanent resident card. If you have been granted asylum, or refugee status, or are adjusting your status, you must submit appropriate documentation from U.S. Citizenship and Immigration Services. If you are on a visa or are an international applicant, you must submit a copy of your valid, non-expired visa.
- **8.** Applicants who served in the U.S. Armed Forces should submit a copy of form DD-214, copy 4.
- **9.** All core application requirements and additional requirements must be received by the Application Deadlines listed above.

Admission to a Degree Program

The undergraduate academic record must reflect an overall grade point average of 2.75 or higher on a 4.0 scale. All undergraduate work is included in the evaluation. Post-bachelor's work in graduate-level courses, if any, is expected to average 3.0 (B) or better.

Admission Categories

Most students who are admitted to NEIU graduate programs are subject only to the standard policies that apply to all graduate students at NEIU. Some students will be offered admission with the following conditional/contingent/provisional statuses. Offers of admission are extended upon the recommendation of the graduate program and the approval of the College of Graduate Studies and Research.

Graduating Seniors: An undergraduate senior who meets all of the requirements for admission to the College and the specific degree program, and is within fifteen semester hours of completing an undergraduate degree may be granted Contingent Admission. Prior to the start of classes in the semester of admission, an applicant granted contingent admission must submit an official transcript showing conferral of the degree in order to start graduate coursework. Courses used to fulfill undergraduate degree requirements will not apply to the graduate degree program of study, unless those course are part of a pre-approved NEIU Accelerated Program.

Conditional Admission: Applicants lacking mastery of certain, specific program prerequisites may be allowed to obtain that mastery by completing prerequisite coursework by a specified time or point in the graduate program, as deemed appropriate by the graduate program. Such applicants will be granted admission and assigned to "conditional status." Students in conditional status will be required to complete their prerequisite work early in their graduate program, in accordance with the sequence of courses recommended by their graduate program.

Provisional Admission: Applicants who do not meet the standard academic background expected for full admission to a degree program, in certain cases, may be granted admission to "provisional status" upon the recommendation of the graduate program and the approval of the College of Graduate Studies and Research. Admission to provisional status may result from an applicant having:

- **1.** A degree from an institution for which academic credit equivalency cannot be established, or one that issues transcripts with ungraded academic records.
- **2.** An undergraduate cumulative grade point average that is below 2.75.
- 3. An erratic undergraduate academic record.

Readmission: Students who do not register for courses within six consecutive semesters (summer included) will be inactivated and must apply for readmission.

Notification of Admission: The Graduate Admissions Office will inform students in writing via the application portal of the admission decision. Students who are admitted should contact their program advisor within two weeks of receiving notification of admission (the advisor's name is identified in the letter of admission), register for the courses they plan to take in their first semester, and participate in orientation programs as specified by the college and/or program.

Admission Acceptance/Deferral: Students are expected to enroll in the semester for which they are admitted, as the application is valid only for that semester. A matriculation deferral for up to one year will be considered by emailing your request to grad-deferment@neiu.edu.

International Applicant Information

An international applicant is a foreign student who plans to apply for or is currently in the United States on an F visa or B1/B2 visa. To apply for admission, you must submit the following documents *in addition to the Core Application Requirements listed above:*

- **1.** An official bank letter(s) from each sponsor. Amounts must be given in U.S. dollars.
- 2. NEIU Financial Statement.
- **3.** If you are currently in the United States, submit a copy of your visa and I-94.
- **4.** If you are currently in the United States, submit a copy of your current I-20.

Once your application is processed, wait for your I-20 to schedule an appointment with the U.S. Consular Office (usembassy.gov).

Mathematics, M.S. - Applied Mathematics Concentration

- Successful completion of a calculus sequence through multivariable calculus and up to 6 mathematics courses beyond the calculus sequence. 3 of 6 courses must be from the following list Linear Algebra, Differential Equations, Probability and Statistics, Numerical Analysis, Modeling, and Operations Research
- Must be comfortable using computational software, such as Maple, Mathematica, MATLAB, or Fortran
- Conditional admission may be granted to students if they only have 4 out of 6 of the courses beyond the calculus sequence

Did you know?

A Graduate Certificate, which can be earned in as little as two to three semesters (depending on how many credit hours are earned per semester), is for students who have already earned a bachelor's or a master's degree. Northeastern's certificate programs allow you to gain a deeper understanding of a specialized topic within a field of study.

A Focus Endorsement is intended for those who already have a Professional Educator License (PEL). The Focus of the program is on you because your unique background will determine, in part, the content of your program to receive your supplemental Endorsement. Upon completion of your Focus program, and passage of any required exams, you will meet current State of Illinois standards for an endorsement in a specialized area.

NEIU's Teacher Licensure Programs (TLPs) are for students who hold a bachelor's degree in an area other than Education and interested in becoming a licensed teacher in Illinois. The TLP programs consist of specialized curriculum allowing students to meet licensure requirements allowing them to teach at levels from birth to 12th grade (depending on program). The TLP sequence provides you with background in educational foundations, curriculum development, and teaching methods, along with field experiences necessary to be successful in today's diverse classrooms.

Financing Your Education

Your education is an investment in your personal and academic development toward a successful future. We are committed to helping that cause while remaining affordable for the average student and family.

Northeastern Illinois University is among the most affordable public universities in Illinois, with full-time graduate tuition cost of approximately \$8,344 for two semesters, based on nine credit hours per semester, for Illinois residents.

For the ninth year in a row, Northeastern Illinois University graduates its students with the least amount of student debt among Midwest regional universities, according to the 2022-2023 edition of *U.S. News & World Report's* annual "Best Colleges" publication. Our in-state tuition rate covers students from neighboring states, as well as military members, including their dependents.

In-State Tuition for Individuals from Neighboring States

Incoming freshmen, transfer and graduate students from neighboring states will be assessed in-state tuition rates. Students qualify if they reside in Indiana, Wisconsin, Michigan, Iowa, Kentucky or Missouri.

Armed Forces Personnel

Any incoming freshman, transfer or graduate student who is an active member of the United States Armed Forces or who is an honorably discharged veteran, regardless of state residency, qualifies for in-state tuition. This policy also applies to the spouse and dependent children of active duty military and veterans.

Financing Your Education - There is a Way

There are many student financial aid resources available to help fund your pursuit of an excellent graduate education, and the Financial Aid Office is available to help you create a financial plan that works for you. The Office offers ongoing workshops on financial aid and has information available on additional grants and scholarships. Getting Started on a Financial Plan

The first step for any need-based financial support is to fill out the Free Application for Federal Student Aid (FAFSA). Even if you're still deciding where you want to study, we urge you to go ahead and fill out the FAFSA form, including the school ID number for Northeastern, 001693. The deadlines for scholarships are often earlier than deadlines for admission, so it's good to start the application process early.

Four Types of Aid

Northeastern offers four basic types of financial aid you can seek to help fund your education. With the help of the financial aid office you can find many options within each category. Eligibility and conditions differ depending on type of aid.

- Need-based grants and scholarships. Free money-you do not need to pay it back. Based on your FAFSA results.
- Merit-based grants and scholarships. Free money-you do not need to pay it back. Based on grades, tests, other criteria.
- Student employment. Compensation for work, while enrolled, that you can use to help pay for your education.
- Loans. Not free money-loans need to be paid back, with interest.
 Federal need-based student loans with relatively good terms are available.

Financial Assistance specific to Graduate Students:

In addition to the information listed above, there is additional information about the financial assistance sources that are specific for graduate students. These include need-based and merit-based tuition scholarships, and graduate assistantships.

- Need-based Tuition Scholarships are awarded based on your FAFSA – you need to submit a Graduate Need Based Tuition Scholarship Application to the Office of Financial Aid. The deadlines for Application submission are July 15 (Fall), November 15 (Spring), and April 1 (Summer).
- A limited number of Graduate Tuition Scholarships (both merit-based and need-based) are available directly from a student's graduate program.
- Graduate Assistants (GAs) are involved in work assignments that further the missions of the university, particularly its teaching and research missions, and that provide the GA with an opportunity to advance their academic experience in the discipline of their graduate program. GAs receive a modest term-based stipend as well as course tuition waiver(s) commensurate with the average weekly time commitment of their assistantship. GAs are primarily recruited directly by the GA hiring unit, but some GAs are recruited from a pool of students who have submitted a New Graduate Assistant Application. Research and Creative Activities Graduate Assistants (RCA-GAs) are selected via an annual competitive application process.
