APPLICATION INSTRUCTIONS AND GENERAL INFORMATION

- Application and all materials, such as official transcripts, test scores, and immigration documents, are required by the application deadline. Course work listed on another school's transcripts are not acceptable. Official transcripts and test scores must be in sealed envelope from the sending institution. Opened transcripts are not considered official. All documents submitted become the property of the University and will not be released to the student or outside party for any reason.
- Courses taken at schools outside of the United States must be evaluated by Educational Credentials Evaluators, Inc (ECE) or World Education Services, Inc (WES). The subject analysis or course by course analysis are required for college or university transcripts.
- If you are a permanent resident of the United States, please submit a clear copy of your Permanent Resident card. If you have been granted temporary residence, conditional entrance, parolee, refugee, asylum, or are in the process of changing status, you must submit appropriate U.S. Citizenship and Immigration Services documentation and/or copy of a valid (not expired) visa.
- Applicants who served in the U.S. Armed Forces must submit a copy of form DD-214, Copy 4. Military educational records may also be submitted for possible transfer credit.
- A note about your Social Security Number: We are requesting your SSN for compliance with federal and state reporting requirements. Your SSN is also required for Financial Aid and also ensure that you are able to claim the Hope Tax Credit. Although you are not required to provide your SSN, it will assist Financial Aid Award processing.
