Northeastern Illinois University does not provide funds for international students. In order to be issued a Form I-20, all international students are required to show proof that they have funds for the first year or semester of study. Proof of funds must be shown during the visa appointment. Please make sure that you will have enough funds for semesters after your first term of study. The amounts of money on page 1 of this form are the minimum needed for one academic year (fall, spring, OR summer term, full-time enrollment) and four months of living expenses. The actual costs may be higher or lower than the amounts on this form.

Legible, scanned PDF copies may be submitted at the time of admission, and then the student must submit original financial statement(s) and bank letter(s) to OIP upon arrival in the U.S. <u>FAXES AND PHOTO COPIES ARE NOT ACCEPTABLE</u>. The documents will become property of the University and will not be returned. Please keep copies of all application documents, including your financial documents. <u>Copies will not be provided to you by the OIP.</u>
